NARRATIVE

Sergeants Malmgren and C. Tell were sent to the 7th Street East of Kellogg in front of the Xcel River Center to assist on an arrest. Sergeant Peck and Officer Leonard advised they had an arrest for Soliciting and Peddling. Mr. Michael Hugh Kelly (dob 8/9/57, 1823 Riverside Av #2, Mpls., MN 55454) was standing by the officers. He was not handcuffed. They detained him for violation of City Ordinance 345.08 Subd a-e.

We walked Mr. Kelly to the squad car. Sergeant Tell did a quick pat search and had him sit in the squad car unhandcuffed. Mr. Kelly brochures were turned over to us.

Per S/C Neuberger, we transported Mr. Kelly to the Old HQ, 100 E. 11th St. While writing out the citation, Mr. Kelly said he was part of the "March on the RNC." He was gathering people to march on September 1st. He is a spokes person for their group with the media.

We issued him the citation (908-200207) and gave him my traffic stop card with Sergeant Tell's name added. I asked Mr. Kelly if he knew where he was? He laughed and said yes. He knew the way back to the Xcel Center.

We had approximately 200 flyers. I took ten and turned them into Property Lab Locker #5.
