**NARRATIVE**

The FBI Special Operations Group developed information to write a search warrant based on surveillance they were conducting on 951/949 Iglehart, St. Paul, MN. Which they transmitted to the SPPD TIC.

Sqd 784 (Langfellow) a Task Force Officer assigned to the SPPD Special Investigations Unit and a member of the FBI JTTF received information to execute a search warrant at 951/949 Iglehart, St. Paul Minnesota.

I received transmitted search warrants at 4:45 hours on 08-30-2008 for the above addresses, signed by the Honorable District Court Judge, Joanne W. Smith.

The search warrants were executed by myself and JTTF FBI SA Chris Langert. I was assisted by MFF Commander Steve Frazer. A soft entry was made at both addresses with no damage to either door.

The postal packages that were searched, were addressed to Fred Tyler at 951 Iglehart. The return address was Robinson Anderson, 3200 Dwight Rd. Ste 450, Elk Grove, CA 95758-6462. The packages contained brochures that were not seized.

Several persons were FI'd at 951/949 Iglehart, St. Paul, MN by SPPD MFF, they were run for warrants and all were released on scene.

A traffic stop was made as a result of the execution of the search warrant. The vehicle was stopped at the intersection of Albert/Osceola, St Paul, MN. The vehicle was a black, cobalt, lic# XXM558. the two occupants of the vehicle were (Shada, Stephen Allen/dob-06-04-1976) & (Cump, Sarolta Jane/ dob-10-08-1970). The

They were identified as Harry Reeves Halpin, 2-15-1979 106 Country Side Ln, Cory CA 94111-9712, Marisa Moran John, 1855 Mission San Francisco, Ca 94103, 2-25-1977 and Emily Pifer Forman. All three were detained until I was advised by officer Dave Longfellow to release them. An article search was conducted for protester devices. All three parties admitted to staying at 951 Eglehart.
