

Attachment 1

1. I am a voter in the Ninth Ward of the City of Minneapolis and I voted in the recent municipal elections. I cast votes for Mayor, City Council, Park Board, and the Board of Taxation and Estimation.

2. On November 6, 2017, the day before election day, I received a mailpiece related to the ninth ward city council race. The mailpiece consisted of a #10 envelope and a two-page, one-sheet (duplex) mailer on standard size paper.

3. Exhibit 1 is a photocopy of the front of the #10 envelope.

4. Exhibit 2 is a photocopy of the front and back of the enclosed mailer.

5. Exhibits 1-2 speak for themselves, but I note the following:

[a] The return address was "Post Office Box 6584, Minneapolis, MN 55406." No other information was given as to the sender.

[b] Most of the mailer consisted of a list of campaign contributions made to the campaign of Gary Schiff, a candidate for city councilmember in the ninth ward. Before that list was the following statement:

I am a concerned citizen and neighbor. I prefer to remain anonymous, but I won't be making an attack on any candidate, so my name should not matter. As a public service, I have copied the Pre-General Election Campaign Finance Report of Gary Schiff Most (85%) of the \$70,545 in contributions itemized on Gary's report comes from real estate developer, business interest, architects and contractors.... [emphasis added]

[c] The mailpiece was postmarked "SAINT PAUL, MN ... 03 NOV 2017".

6. I spoke to several friends who live in the Ninth Ward and they too received such a mailpiece.

7. On information and belief, this mailpiece was sent to a large number of potential voters in the Ninth Ward.

8. On November 10, 2017 I submitted a REQUEST FOR CHANGE OF ADDRESS OR BOXHOLDER INFORMATION NEEDED FOR SERVICE OF LEGAL PROCESS to the post office at 3033 27th Ave S, Minneapolis, MN 55406 (see <http://sitpx-about.usps.com/who-we-are/foia/39cfr265-266.rtf>)

9. The postal clerk looked up the box renter's name and address for Post Office Box 6584, Minneapolis, MN 55406. He reported that the name and address was:

Steven Minn
7 Overholt Pass
Minneapolis, MN 55439

"7 Overholt Pass, Minneapolis, MN 55439" is one way to give the address for a house that is actually in Edina, MN with the address "7 Overholt Pass, Edina, MN 55439."

The postal clerk also told me that the box had been rented starting only about one month ago.

10. A person living at 7 Overholt Pass, Edina, is not my neighbor. Indeed he not only does not live in my neighborhood, he does not live in my ward or even my city. He lives 8 miles as the crow flies from me and 4 miles as the crow flies from the nearest point in Minneapolis (the SW corner of the Thirteenth Ward).

11. The post office at 3033 27th Ave S, Minneapolis, MN 55406 is in the Ninth Ward and in a general sense is in my neighborhood.

12. The mailpiece was intended to make the reader believe, contrary to fact, that it was sent by a neighbor, surely by someone living in Minneapolis and probably by someone living in the Ninth Ward.

13. Minn. Stat. § 211B.04, parts (a) and (e) provide as follows:

(a) A person who participates in the preparation or dissemination of campaign material other than as provided in section 211B.05, subdivision 1, that does not prominently include the name and address of the person or committee causing the material to be prepared or disseminated in a disclaimer substantially in the form provided in paragraph (b) or (c) is guilty of a misdemeanor.

(e) This section does not apply to an individual or association that is not required to register or report under chapter 10A or 211A.

14. The mailer was campaign material. It did not "prominently include the name and address of the person or committee causing the material to be prepared" and instead was sent "anonymous[ly]" and to the extent it said anything about the sender the statement was misleading.

15. On information and belief, this particular mailer was sent to a large number of voters such that the production and mailing cost (very likely even without the cost of the box rental) exceeded \$750.

16. On information and belief, the physical act of printing the mailer and stuffing the mailer and otherwise preparing and drafting the mailpiece involved more than one person.

17. Steven Minn of 7 Overholt Pass is the same Steven Minn who was very active in the recent election. He was a major player in a group called "Minneapolis Works!" that spent over \$100,000 trying to influence the recent Minneapolis municipal elections.¹ For example, see the MinnPost article cited in footnote 1 and two other articles cited in footnote 2.²

18. Minneapolis Works! disseminated multiple pieces of campaign literature, including one or more pieces in the Ninth Ward in opposition to Gary Schiff's candidacy. Minnesota Works! supported the candidacy of Mohamed Farah, one of Gary Schiff's opponents. Exhibits 3-4 are copies of such literature.

¹The chance that the renter of the post office box is not the Steven Minn associated with Minneapolis Works! is essentially zero. Whitepages.com lists only one Steven Minn in Minnesota and lists him as a roommate of (and presumably husband of) Lucille Minn with a present address of 7 Overholt Pass, Edina. Several news articles discuss Steven Minn's major involvement in and contributions to Minneapolis Works!. See, e.g., "What the Latest Independent Expenditure Reports Tell Us About Minneapolis' Mayor and Council Races", MinnPost, 11/2/17, by Peter Callaghan. That article links to a campaign finance report by Minneapolis Works! which lists Steven Minn and Lucille Minn, both of 7 Overholt Pass, Edina, as contributing \$5000 each, the most except for James Lawrence.

19. Even excluding the prior two paragraphs, Steven Minn was part of a committee within the meaning of Minn. Stat. § 211A.01, subd. 4 and this committee had a duty to report or register within the meaning of Minn. Stat. § 211B.04(e).


20. Therefore, even excluding paragraphs 17-18, this committee as a group, and Steven Minn as an individual, violated Minn. Stat. § 211B.04(a).

21. Taking into account paragraphs 17-19, Minneapolis Works! as a committee and Steven Minn as an individual violated Minn. Stat. § 211B.04(a).





Most (85%) of the \$70,545 in contributions itemized on Gary's report comes from real estate developers, business interests, architects and contractors who will appear before Zoning & Planning in the future. Gary chaired Zoning and Planning for 12 years and wants to return to that post. His previous year's reports are on the same portal, and are worthy of review.

I hope my neighbors will find this information useful when thinking about who the next City Council Member from Ward 9 should be. Remember to Vote!





